

TARIFF AUTHORITY FOR MAJOR PORTS

Mumbai

The Tariff Authority for Major Ports, a Statutory Body under the administrative control of Ministry of Shipping, Road Transport and Highways, of Government of India, invites applications for filling up ONE (1) post of **ASSISTANT DIRECTOR** in the pay scale of Rs. 15,600 - 39,100/- +Grade Pay of Rs.5,400/- from candidates belonging to Other Backward Class (OBC). The gross pay at the minimum of scale is Rs.35,824/- including all applicable allowances as on date. The post will be filled up on direct recruitment basis. The details of the post and the eligibility conditions thereof are given below: -

A. Essential

- (i) Qualifications recognized for enrolment in the Register of Members of the Institute of Chartered Accountants of India or of the Institute of Cost and Works Accountants of India or equivalent ;
- (ii) Five years experience in costing / finance / tariff fixation matters relating preferably to ports or other Regulatory Authorities.

(B). Desirable:

Degree of a recognized University or equivalent preferably in Commerce and Accounts.

(3). Age limit

- (i) Not exceeding 35 years.
- (ii) Age shall be deemed as on the first day of the calendar year. The crucial date for determining the age limit shall be the closing date for receipt of applications from candidates.
- (iii) Age specified shall be relaxed in accordance with the orders/instructions relating to the matter issued by the Government from time to time.

2. The pay of the official selected for appointment to this post will be regulated as per the Rules followed by this Authority. Suitable accommodation will be provided in the quarters provided by Mumbai Port Trust on terms and conditions applicable to government servants, subject to availability.

3. Applicants employed in Govt. Departments / Undertakings etc. should submit their applications through proper channel with a certificate from competent authority that the particulars furnished by the officer are correct, no disciplinary / vigilance case is pending or contemplated against the applicant and he / she is clear from the vigilance angle alongwith integrity certificate and attested copies of the ACRs for last five years.

4. Interested candidates may forward their applications affixing a recent passport size photograph furnishing – Name in block letters, Father's / Husband's Name, Address for correspondence, Age & Date of Birth, Educational Qualification - Essential & Desirable, Whether belongs to OBC Category, Work experience with details of pay & duties and Any other relevant information alongwith attested copies of certificates, proof of educational qualifications, date of birth and Caste certificates to the Section Officer (Admn.), Tariff Authority for Major Ports, 4th floor, Bhandar Bhavan, Muzawar Pakhadi Road, Mazgaon, Mumbai-400 010 **on or before 10th August 2009**

5. The service conditions of the selected candidate shall be regulated in accordance with the Tariff Authority For Major Ports Regulations and applicable rules in force from time to time.
