**ORDER**

(Passed on this 5<sup>th</sup> day of July 2013)

The 'Guidelines for Regulation of Tariff at Major Ports, 2004' were notified in the Gazette of India on 31 March 2005 vide Gazette No.39 by this Authority in compliance of policy directions issued by the Government of India under section 111 of the Major Port Trusts' Act, 1963. These guidelines came into effect from 31 March 2005 and as stipulated in clause 1.2 of the guidelines, will remain in force for a period of 5 years, i.e. up to 31 March 2010, unless reviewed earlier or extended by this Authority.

2. As advised by the Government of India in the Ministry of Shipping this Authority extended the validity of the 'Guidelines for Regulation of Tariff at Major Ports, 2004' from time to time and the last extension till 30 June 2013 or until further orders whichever is earlier was notified in the Gazette of India on 26 March 2013 vide G.No.84.

3. The Government of India in the Ministry of Shipping now, vide its letter No.PR-14019/20/2009-PG(pt-II) dated 4 July 2013, has requested this Authority to further extend the validity of the 'Guidelines for Regulation of Tariff at Major Ports, 2004' till September 2013 or until further orders, whichever is earlier.

4. Accordingly, the validity of the 'Guidelines for Regulation of Tariff at Major Ports, 2004' is further extended till September 2013 or until further orders whichever is earlier.
